To avoid risk of injury, never leave an infant unattended and do not leave sheets, blankets, pillows or other items in the bassinet with the infant.


Use the pull-out chart board only as a writing surface. Do not sit or lean on it, or apply excessive weight to it, or tipping of the bassinet could occur and injury could result.

To prevent the bassinet from tipping and causing injury, do not place more than 25 pounds (11 kilograms) in the bassinet drawer.

Push the bassinet only from the ends. Do not push the bassinet from the sides or tipping of the bassinet could occur and injury could result.

When putting the bassinet into Trendelenburg/Reverse Trendelenburg, verify the "J" hook is engaged and secure before releasing the tub or injury could occur.




WARNING


PROPER BASSINET PUSHING TECHNIQUE



WARNING

Push the bassinet only from the ends as indicated by the illustrations above. Do not push the bassinet from the sides or tipping of the bassinet could occur and injury could result.

TRENDELENBURG POSITIONING



BASSINET IN TRENDELENBURG POSITION

To put the bassinet into the Trendelenburg/Reverse Trendelenburg position, lift up on the tub, then lower it until the hook engages securely with the end rail (see above).

WARNING

When putting the bassinet into Trendelenburg/Reverse Trendelenburg, verify the "J" hook is engaged and secure before releasing the tub or injury could occur.



CLEANING

To clean the bassinet cabinet, wipe it with a soft cloth and a mild soap and water solution. Rinse thoroughly. Clean the bassinet tub with a mild anti-bacterial soap and warm water solution. Rinse thoroughly.


CAUTION


Modern–Style Bassinet Assembly









Damaged Merchandise:

ICC Regulations require that claims for damaged merchandise must be made with the carrier within fifteen (15) days of receipt of merchandise. In the event that this information is not received by Stryker within the fifteen (15) day period following the delivery of the merchandise, or the damage was not noted on the delivery receipt at the time of receipt, the customer will be responsible for payment of the original invoice in full.

Claims for any short shipment must be made within thirty (30) days of invoice.
