Hill-Rom, Inc. (Hill-Rom) has a long tradition of providing superior products and service to our customers. Our goal is "Total Customer Satisfaction". In that spirit, Hill-Rom is proud to offer the following warranty.

SPECIFIC WARRANTY

This warranty applies only to defects in workmanship and materials and only to damages arising from normal usage on a non-prorated basis for a period of five (5) years for foam and internal components and three (3) years for cover and external components from the date of original purchase. Any damages that arise from abnormal use such as those caused by improper handling, cleaning, or negligent use are excluded from this warranty. Hill-Rom's obligation under this warranty is expressly limited to supplying replacement parts or replacing, at its option, any mattress which is, in the sole discretion of Hill-Rom, found to be defective. No returns, allowances, credits, discounts, charge backs, or other deductions will be made without Hill-Rom's prior written authorization. This warranty cannot be modified by any employee or representative of Hill-Rom or any agent thereof except in writing signed by an officer of Hill-Rom.

Shipping and handling charges incurred in connection with this warranty during the first year will be paid by Hill-Rom, but thereafter are the purchaser's sole responsibility.

The purchaser is hereby advised that some fabric will stretch, and all foam will lose some of its resiliency during its life. This is normal and is not included in this or any other warranty applicable to this product. This warranty is void if the manufacturer's tag is removed.




Figure 1-1. Product Identification Label Location

Exchange Policy

In-Warranty Exchanges

In some cases, Hill-Rom will request that parts/products be returned for inspection. When this occurs, you are expected to return parts/products within 30 days of receipt of the exchange part. If you fail to return the inoperative parts/products within the 30 day period, Hill-Rom will invoice your facility for the full selling price of the parts/products.

NOTE:

The preceding billing procedure pertains **only** to parts/products that Hill-Rom requests to be returned.

In some cases, the invoice accompanying the parts will show the full selling price (only for internal use at Hill-Rom). Do not confuse this price with your price.

Do not return any parts without an RMA number. When parts/products have been requested to be returned, Hill-Rom will include an RMA packet with the parts/products shipment. If an RMA number is not available, obtain one by phoning Hill-Rom Technical Support at (800) 445-3720.

Out-of-Warranty Exchanges

You are expected to return the inoperative parts/products within 30 days of receipt of the exchange part. Hill-Rom will include an RMA packet with the parts/products shipment. If an RMA number is not available, obtain one by phoning Hill-Rom Technical Support at (800) 445-3720. Hill-Rom will invoice your facility for the full selling price of the parts/products. Upon return of the inoperative parts/products, Hill-Rom will issue a credit to your facility for the difference between the exchange price and the full selling price of the parts/products.







1.1 Installation



CAUTION:

The mattress may be exposed to extreme temperatures during shipping. Allow the mattress to adjust to the room temperature before unpacking. Failure to do so could result in equipment damage.

1. Before unpacking, allow the mattress to adjust to the room temperature.




WARNING:

Ensure the mattress is installed with the foot symbol facing up at the foot end of the bed frame. Failure to do so could result in personal injury or equipment damage.

2. Install the mattress on the bed frame with the foot symbol (A) facing up at the foot end of the bed frame (see figure 1-5 on page 1-25).

WARNING:

Allow any folded mattress to renew its shape for 1 to 2 hours before placing a patient on the surface. Failure to do so could result in equipment damage or patient discomfort.

- 3. After the mattress is installed, allow the mattress 1 to 2 hours to renew its shape.
- 4. Install a sheet over the mattress. Ensure the sheet fits the mattress properly.

1.2 General Cleaning and Inspection

Ensure compliance with Occupational Safety and Health Administration (OSHA) regulations and Centers for Disease Control and Prevention (CDC) recommendations relating to bloodborne pathogens. To disinfect the mattress, use an intermediate-level disinfectant registered with the Environmental Protection Agency (EPA). When disinfecting, follow the standard precautions and the manufacturer's instructions.

Mattress Disinfection



CAUTION:

Do not expose the mattress to excessive moisture. Equipment damage may occur.

- 1. Remove visible soil from the mattress surface by wiping the mattress with a soft cloth or paper towel dampened with soapy water.
- 2. Disinfect the mattress with an EPA-registered, intermediate-level disinfectant.
 - a. Follow the manufacturer's recommendations for use and dilution.
 - b. Do not saturate the material or allow cleaning solutions to pool on the mattress.
- 3. Allow the surface to air dry.

Exterior Mattress Inspection



CAUTION:

Do not use a mattress with damaged components. Equipment damage could occur.

- 1. Inspect the cover for cuts, rips, cracks, or tears. Do not use a mattress with damaged components.
- 2. If the cover is damaged or has a stain that cannot be removed, set the mattress aside, and notify Hill-Rom according to your facility's call-in policy.




Figure 1-6. Mattress Interior Inspection

2. Inspect the HY•TEX Bi-StretchTM Cover or HY•TEX NylonTM Cover (A), Anti-ShearTM Inner Liner (C), and bottom cover (B) for soiling or damage.

3. If any components are soiled or damaged, set the mattress aside, and notify Hill-Rom according to your facility's call-in policy.



CAUTION:

Do not remove the flame barrier (if present) from the mattress core. Equipment damage may occur.

- 4. Inspect the flame barrier (D) (if present) for soiling or damage.
 - a. If the flame barrier (D) is soiled or damaged, set the mattress aside, and notify Hill-Rom according to your facility's call-in policy.
 - b. If the flame barrier (D) is not present, inspect the mattress core (E) for soiling or damage.
- 5. If the mattress is damaged or has soiling that cannot be removed, set the mattress aside, and notify Hill-Rom according to your facility's call-in policy.





 - c. Ensure any excess flame barrier (C) is under the foot end of the mattress core (B).
